# *E. Lake Vegetation* (D. Gustafson)

- Had planned on treating next week but obviously the current conditions don't allow it (ice cover)
- Applied for grant in March
- Reimbursement amount lowered from \$500/care to currently \$100/acre and this is expected to continue to go down-we will need to prepare to have an increased portion to pay
- DNR rules have changed-if lakes have poor quality, treating invasives is not the best practice and they will likely not approve permit.
- New rules published on website
- If you want to treat more than 15% of shallow areas, you need to have completed a plant survey the year prior and have a DNR approved lake management plan, and have a qualified NON-applicator group delineate the treatment area first.
- Dale is confident we will be approved because of our history
- New rules regarding signature collection before treatment-in the past had to have written permission from every property owner. Now we just need to notify them of their rights and how to exercise their rights. Don needs help with the mailing for this.
- Paul suggested we include a paragraph to nonmembers letting them know that SLA is paying for the treatment.
- Charlotte asked if we should finalize the plant management draft we have started. Dale responded it will give it more legitimacy if we have Steve McComas do it
- Dale shared additional info about the Lakes and Rivers Advocates Group
- Organizations agreeing more than ever-all focused on invasive species
- DNR lacks funds
- LRAG is trying to get a network of people to mail their legislators expressing their concerns especially right before crucial votes.
- Trudy recommends the board be very cautious doesn't think the board should become involved in politics
