- Water 8 inches above door

C. Water Quality Statistics –7-16-14 (D. Erdmann)

- Culvert Inlet 21.5"
- Outlet 26.5"
- Water Clarity 15 ft, very clear only slightest tint of green from algae
- Water Temp 74 degrees at 15 ft
- Air Temp 70 degrees
- Physical water condition 1 on a scale of 1(good) to 5 (poor). Very high algae content.
- Slow flow thru culvert
- Have spotted over 10 Loons on the lake
- Have been seeing an Eagle on the north shore

D. Lake Improvement (D.Gustafson)

- D. Gustafson made motion to get contractable bids for the Hollister/Hart water quality project and consider doing half or all of the project. Dale described a potential solution for the project and provided a diagram of the project area. Project would reduce the roadway contaminants from going into the lake.
