A. Chairman's Report (Elsner)

Lake level has dropped one foot

- C. Quiggle requested that in the future the info include what the level is in reference to the ordinary high water mark.
- DNR installed the scale used to determine the high water level. Currently 15.5 inches equals ordinary high water mark. Some believe this is not accurate and should be re-

- evaluated. Caution given that this could create problems for property owners who want permits as property becomes smaller as the ordinary high water level is raised.
- Elsner asked for info regarding location and procedure for setting the scale. Believes we will need to make sure we have an established accurate number before we recommend a permanent wake ordinance.
- D. Peterson shared a rough calculation of the rate of flow of water out the culvert. At 4600 gallons per minute it would take 4 days to drop the level of the 1060 acre lake 1 inch.
- In 2010 the culvert reading did not ever go below 21 inches.
- Ordinary high water mark was set out of a lawsuit in the 1950s. Don Peterson has the info and will share at a later date.
- Zebra Mussel Volunteer Report form
- Dale Gustafson recommends that everyone do a close inspection of anything we take out of the lake this fall to look for any infestation.
- Include this info in Newsflash and in SLA Newsletter
- Call/email Dale G. with any questions or if you find anything.

C. Lake Vegetation (D. Gustafson)

- Difficult to find Eurasian Water Milfoil this summer. Hired PLM out of Brainerd. The gathered 160 samples in 2 days and generated a spreadsheet of all lake vegetation. They found EWM all over the lake, but it was short and single or small groups. PLM recommends treating 6 spots. Request for fall treatment has been sent to the DNR. If not, next spring.
- C. Quiggle asked about use of Association pontoon for fall treatment. Dale said no, will probably hire it out. The longer you can have it on, the better it works, so he splits it into two treatments several hours apart.
- In Dale's opinion, we should pay to have an outside group to do a vegetation study every other year and hire Steve Nicomus to look at this data plus that from the DNR and from his study from 8 years ago to help create a lake management plan to help protect the native species and fight invasives.
- Stewart/Purcell rain garden project (Hollister Ave.)
- Citizens meeting with soil & Water to discuss project design
- SLA project was designed to improve lake water quality, not flood control, and even if it had, the significant rain we had over a short period of time would have been too much for it to handle.
- Farmers don't have to abide by the same soil erosion control rules that residential construction does.
- If interested in a tour of the Hollister project that drains a large field, contact Karen Sutherland.
