- Ed Quinn spoke about the water quality using the Total Phosphorus, Chlorophyll, Secchi Depth- no significant trend Collecting water samples for many years. Looking for someone to take responsibility for the data collection- 5 times a year. Wright County Soil & Water has a training session in the spring, at the Annandale Middle School. – The following people volunteered: Ken VandeSteeg, Paul Gustafson, Andrea Welter. Ken will take the lead and coordinate with the other volunteers

- This water collection data is valuable for monitoring lake water quality.

Insurance Update

- Gen Liab Currently protects property damage and injury (Annual Picnic, Fund Raiser, Lake Assoc events)
- Director and Officers Insurance: Fraud and Money Management. D&O insurance does not cover first party losses like theft by a director—a fidelity bond would be required for that. It is for third party lawsuits. It provides legal expense coverage for the board and protects the assets, the \$200K bank account, of the SLA.
- State Law indicates a volunteer from a non-profit can not be sued
- Currently no insurance on pontoon boat, motor, boat lift, Need liability insurance
- Is \$1,000,000 enough Gen Liab? Generally need insurance to protect the value of the assets
- Gen Liability handles property up to the lake
- Need expressed for boat liability insurance

D. Water Quality (D.Gustafson)

- Soil and Water money goes to lakes in peril –Sugar Lake is not in peril.
- Some money available for clean water protection.
- 2 major projects could need \$100,000. Hollister needs to be done, Brent Jude, in favor of moving ahead with the project. Ponding area in the field, would help for medium rainfall. Could be started this winter.
- Hollister and 110th Grating on the roadside,
- 26 culverts going into Sugar Lake.

E. Vegetation (D.Gustafson)

- With new equipment, The new BioBase equipment and service is providing a more detailed and thorough picture of lake vegetation than we have ever had.
- Health of the lake really good
- Concern about bullrush with low water levels That is actually when bulrush expands
- Algae takes advantage of high nutrient levels. Had more filamentous algae than green algae this year.
