## SLA Board adopts two focus issues for 2011

In addition to regular activities and the continuing work fighting aquatic invasive species, the Board of Directors agreed to focus on two areas this year:

#### 1. Rain Water Management

#### Education:

- Instill in lakeshore owners a sense of responsibility for every drop of water that falls on their property.
- Increase the understanding of the harm caused by runoff from hard surfaces, (roof tops, patios, extra structures, and compacted soils). Increase the appreciation of the beauty of native plants by the shoreline.

#### Action:

- Identify additional projects (large and small) that can improve the quality of the water that flows to the lake.
- Design solutions and secure funding to complete the most important projects on the list.
- Identify sources of help (money and expertise) with these projects.
- Dramatically increase the number of lineal feet of native shoreline on the lake. Increase the number of rain gardens in the shoreline impact area.

#### 2. Zebra Mussel Awareness

#### Education:

• Educate all Sugar Lake users to be able to identify Zebra Mussels and to understand the potential harm they can cause Sugar Lake.

#### Action:

- Increase the monitoring of public access to increase awareness of the seriousness of possible Zebra Mussel infestation. SLA has committed \$3,875.00 to pay for extra monitoring by DNR trained workers, but much more is needed.
- Conduct classes for volunteer access monitors.
- Establish the Sugar Lake "Zebra Watch". Get 2 volunteer families for each Sugar Lake shoreline area to be Zebra Watchers. Volunteers will install a "Zebra Trap" at the end of their dock and inspect and record the presence or absence of Zebra Mussels every week. They will send in monthly reports by e-mail to be included in the "over-all" Sugar Lake reports that will be submitted to the state. We will establish a proof log of no Zebra Mussels in Sugar Lake. Continue to fund our Invasive Species Budget so if we do get Zebra Mussels, we will be financially ready to deal with them if a cure is developed.

#### **Vegetation Committee** Update By Dale Gustafson

- We have signed up for a comprehensive aquatic invasive species(AIS) risk assessment with Environmental Sentry Protection, LLC and Osgood Consulting, LLC. This is a program that is under development and we are a 'beta' client that will be helping to develop the program. This should give a thorough outside look at our AIS risk.
- We have been approved by the DNR for a \$26,500.00 grant to help pay the Curly leaf pondweed treatment this spring
- We will soon begin our search for Curly leaf pondweed and Eurasian water milfoil. We are concerned that the early snow last fall and continued deep snow cover over the winter could have slowed the growth of these two species so they may be difficult to locate in time for the spring treatment. We know they are there, but we have to find them to treat them. We can always use more volunteers to search. Contact one of the Vegetation Committee members (Dale Gustafson, Dan Erdman, Don Peterson, etc.) if you can help.
- We still expect to locate and treat some areas in May, but we will not know where or when until time of treatment.
- Your dock or shoreline will be posted with a sign if your area is treated. We will also send a newsflash detailing the treatment plan. Do not use lake water for irrigation if your area was treated. All other lake activities are safe. We will sample the water after treatment, and as we hear from the laboratory it is safe to use lake water to irrigate we will send out an email news flash and post a note on our website. Last year that was a period of about two weeks. It could be less or more time depending on conditions.
- Be prepared to have your irrigation system off at that time. It generally is a good thing not to use you irrigation much in the spring. Your lawn will be much healthier if it searches out moisture in the soil before you supplement water with you irrigation system.
- We plan to do additional treatments of EWM later this year if needed, and we will do this with our own volunteers in late June or July. We will use the News Flash e-mail for this as well so be sure you are on that list.

#### CORINNA TOWNSHIP AND WRIGHT COUNTY REACH ONE-YEAR AGREEMENT ON ZONING AND BUILDING CODE ADMINISTRATION

On December 28, 2010, the Wright County Board of Commissioners and the Corinna Township Board of Supervisors reached an agreement regarding the administration of septic system permitting and zoning ordinances in the shoreland areas of Corinna Township; this agreement will be in effect through the end of 2011, at which time it will be re-assessed.

The agreement specifies that:

- Corinna Township will administer all land use (zoning), floodplain, building and septic permitting, with building and septic system permit review and inspections being conducted by Wright County staff;
- Corinna's zoning staff will conduct land use permit reviews and inspections related to the Zoning Ordinance;
- Applicants will drop off all applications and pick up and pay for all permits at Corinna Town Hall.

With the exception of rezoning of properties, all land use public hearings (variances, conditional use permits, preliminary plats, etc.) will be handled completely by Corinna Township and there will be no need for applicants to obtain final approval of such applications from Wright County.

The agreement is the result of more than four months of negotiations between County and Township officials. The Corinna Township Board would especially like to thank Wright County Commissioner Rose Thelen for her tireless efforts to bring this agreement to reality. ## **Restore Your Shore**

The computer program 'Restore Your Shore' has been available for a number of years. It is an excellent reference and has been used extensively for projects on Sugar Lake. It has been updated and is now available online. Here is the news release from the University of Minnesota Shoreland Education News:

*Restore Your Shore* is a powerful multimedia program for shoreland owners and professionals to use in implementing shoreland restoration and protection projects.

The Restore Your Shore program will enable you to:

- Develop a deeper understanding of shoreland ecosystems and natural shoreland management.
- Discover how lakeshore problems similar to your own have been resolved through innovative approaches. Follow four different shoreland owners' experiences as they share their shoreland transformation projects.
- Create your own plant list from an extensive interactive database of over 400 native plant species (photos included!). Select native plant species suitable for planting in your area. Find out what to plant and what *not* to plant.
- Use worksheets and forms that will guide you step by step through the design and implementation process. Watch your project unfold and enjoy the transformation that takes place.

We will be highlighting a Wright County native plant in the summer newsletters this year. The plant this month is the:

#### **Blue Flag Iris**

Iris Versicolor

Also known as-Northern blue flag

- Likes sun to partial shade
- Wet, moist, rich soil. Grows well along lakeshore
- Height: 1.5 feet to 2.5 feet
- Spreads by self seeding and extension of its rhizomes
- Blooms from May to June
- Blue to Violet-blue flower, variegated with yellow, green, and white

Winter meeting

The winter meeting was held February 12, 2011, at Cabella's in Rogers. After a board meeting, 41 attendees listened to featured speaker, Jeremy Williamson.

Jeremy is a Water Quality Specialist and the Aquatic Invasive Species Coordinator with the Land and Resources Department in Polk County Wisconsin. He spoke about boating impacts on lakes including turbidity and sediments, shoreline erosion, aquatic plants, wildlife, and the dispersal of aquatic invasive species.

Business topics at the board meeting included a lengthy discussion about Sugar Lake water levels. A committee was charged with pursuing further information regarding high water levels. An additional \$2500 was approved for landing monitoring by the DNR Stop Aquatic Hitchhikers program in 2011.

Dale Gustafson gave a short update on our recent DNR vegetation survey and discussed the need for additional surveys in 2011.

## Water Quality Committee Update

- We plan on planting more Bull Rush this year in late July or early August. We are interested in developing more sites. If you are interested in helping or planting at your property email Dale Gustafson at dalegus@earthlink.net.
- We will be attending annual training for monitoring which will start in May. If you are interested in seeing the data that is collected go to the RMB Environmental Laboratories website at http://www.rmbel.info/

click on the 'Lakes Monitoring Program' link , then the Lakes Monitoring Database' and search for Sugar Lake data.

- Last summer and fall we had high water levels and some heavy wind causing damage to many shorelines. These areas need to be repaired as soon as possible to limit the time that soils erode into the lake.
- You can replace your rock by hand, and re-sod bare areas, but it is much better if you restore your shoreline by planting native plants. It is not legal and very bad for the lake to just push the soils back into the water. This action releases large amounts of phosphorus into the water causing more algae growth. There are many alternatives to rock riprap for your shoreline. Be a good steward of the lake and re-vegetate your shoreline. ## Zebra Mussel

Zebra Mussels are an invasive animal that were likely brought to North America in the ballast water of cargo freighters. They were discovered in Lake Erie in 1988.

They are a small freshwater mussel about one to two inches long with a yellow and brown striped shell. They attach themselves to any hard surface in the water.

Currently 19 lakes are infested with a total of 50 lakes designated as infested due to connections between the lakes. Fish Lake is the only Wright County lake infested at this time but several Hennepin County lakes are infested including Lake Minnetonka.

Zebra mussels can spread by attaching to boats or aquatic vegetation. They are most easily spread as microscopic larvae (called veligers) in bait buckets, live wells, or other water. Currently there are no safe control methods to eradicate Zebra mussels once they are established. Prevention is the best tool available.

When moving between lakes:

- Clean—Remove any mud or aquatic plants from your equipment
- Drain—Drain your bilge, live wells, bait buckets
- Dry—Anything that came in contact with the water. Allow at least 5 days for all equipment to dry if you are coming from an infested lake or spray with high pressure hot water (above 120 degrees Fahrenheit.)

Zebra mussels compete with young fish food, they block underwater pipes like irrigation supply pipes, block cooling intakes on boat motors, and their shells are sharp presenting a hazard when walking in the lake and on beaches.
