Thank you firefighters

Sugar Lake Association would like to thank the many firefighters and other emergency professionals who responded to save the northwest side of Sugar Lake. Crews from Annandale, Maple Lake, Clearwater, and MNDNR as well as a helicopter from the DNR battled the blaze for several hours April 7. The fire started around 3 p.m. on the west side of the DNR wildlife management area along Illsley Ave. It is believed to have been caused by a discarded cigarette. Thirty mph winds drove it west towards Sugar Lake. About 100 acres of the wildlife area were burned. The blaze burned right up to the back yards of homes along Hollister Ave. where it was mostly contained by 8:30 p.m. The DNR helicopter, contracted from Brainerd Helicopter and piloted by Lee Andrews, is credited with being the most effective firefighter on the scene. The helicopter scooped up water in a bucket, 125 gallons at a time, and dropped it on the fire.

Approximately 45 firefighters from the three city departments responded as well as 20 DNR "smoke chasers."

This should also serve as reminder to everyone to NOT BURN LEAVES and watch campfires always. The DNR has imposed burning restrictions that include Wright county as of April 1. Burning restrictions continue for four to six weeks or until the vegetation has greened up enough to decrease the fire danger.

The Sugar Lake Association (SLA) is committed to protecting and preserving the resources that contribute to the natural beauty of Sugar Lake; as well as preserving and improving it's water quality. We feel there is a need for the ongoing education of current and future lake residents. To help promote this mission, the Water Quality Education Committee of the SLA, would like to offer a scholarship opportunity to any SLA member, child, or grandchild of a member, who will be attending any post-secondary school in the fall of 2004.

Lake Vegetation

The board approved an amended budget proposal for vegetation this year. Major areas include:

- **Permit issues:** We need to get signatures of everyone on the lake so we can treat when we need to. We have 107 and need 250 more. Letters with self-addressed envelopes will be sent and list of remaining property owners will be given to Area Communicators for collecting the last signatures. Approximate cost \$250.00
- **Milfoil:** Hire Buddy Divers to do a complete lake survey with divers in preparation for 2004 treatments. A lake survey by divers will allow us to establish a baseline now when we have good water clarity. This survey will also establish that we do not have other large patches of milfoil we are missing. Cost \$9,200.00 for initial survey. Treat areas of worst infection with chemical on hand (Estimated treatment 20 Acres)
- **Sensitive Vegetation Buoys:** Replace 7 old buoys at \$125.00 each = \$1,054.00
- **Re-vegetation Projects:** Identify 3 important areas in lake for replanting and organize planting projects. Budget amount \$1,000.00
- **Curly Leaf Pondweed:** Identify areas for treatment as soon as ice goes out. Treat areas with Hydrothal Super K in April or May. Estimate 20 acres at \$300.00 per acre = \$6,000.00

This year Sugar Lake will begin to treat Curlyleaf Pond weed. This exotic plant is fast becoming the number one foe for a healthy lake. It's life cycle is extremely destructive to the health of the lake. Over the winter and into the very early spring it withdraws nutrients from the sediment of the lake and after forming its seeds (turions) for the next year, it dies down and releases the nutrients back into the water to allow more algae to grow and reduce water clarity thereby harming good native vegetation. If this is not controlled, the results are disastrous. We will start the treatment this year in an attempt to break this cycle. We will be treating several areas in May to reduce the quantity of seeds produced. This battle will take patience, but we need to do something. We will keep you posted on our progress.

Declining Water Clarity in Sugar Lake

Shocking words to read! The MPCA (Minnesota Pollution Control Agency) published a report in November 2003 titled "Wright Co. Secchi Transparency." In the report water transparency trends for Wright Co. lakes are listed as improving, not changing, or declining. Twenty-seven lakes in Wright County met the minimum data requirements for trend analysis. Of the twenty-seven, seven exhibited improvement, seventeen no change, and three significant decline in transparency over time. Sadly, Sugar Lake is one of the three with declining transparency.

The data used for trend analysis are secchi transparency readings taken by volunteer lake monitors in the MPCA's Citizen Lake Monitoring Program (CLMP). Secchi transparency is one of the best parameters for determining a lake's overall health. It provides an indirect measure of the amount of algae in the water. In order to be part of this analysis a minimum of four readings per summer for eight or more years were required. Sugar Lake has secchi transparency data dating back to 1974.

Please consider this rating a challenge to property owners around Sugar Lake. It takes years for trends in lake water quality to develop. It is time to start a positive trend. Watch this newsletter and other communications from your lake association for ideas about what you can personally do to improve the water quality of Sugar Lake.

Buoys Teams

The Sugar Lake Association Vegetation Committee needs your help.

In the past, we have had a very small group of dedicated people to handle the installation and removal of our lake buoys. These buoys are very valuable from an education standpoint and need to be installed each year. Over the past several years a number of the volunteers who have done the work have had to decline to do it because it was too hard on their backs. We have now replaced most of the heavy buoys with lighter ones, and we own a pontoon to do the work.

The committee feels the best way to handle this task is to divide up the work into three teams. North Lake, West Side, and Southwest Side.

These teams would use the Association pontoon and install and remove them at a time convenient for them. Ideally they would store them in their area and bring them out as needed.

The spring work is easy and not very messy; in the fall the best way to do it is to have a brush with and clean the buoys before bringing them on the pontoon. I think we will devise a winch system this summer so lifting will not be a problem. The buoys weigh 49 lbs, and the weights about 40 lbs with a section of chain attached.

Please let me know if you could help in this effort and find a couple of your neighbors that would help with the task.

Attention Sugar Lake Gardeners **New Shoreline Gardener's Group Forming!!**

"Lakescaping is where it's at"... These were the words spoken by Valerie Prax, U of M Extension Educator, at a Shoreland Volunteer Training Session on March 13. Several SLA members attended this meeting and found out why native vegetation is good to have in the water and on the shoreline:

1. It filters runoff water heading into the lake, helping to improve water quality.
2. 90% of all lake life is born, raised, and fed in the area where land and water meet. Healthy Lakeshore=Healthy Lake Life
3. It's hard to manage fish on lakes without healthy lakeshore. We need to protect their habitat as 90% of fish in the lake come from natural reproduction, not stocking.
4. Plants and roots are the most effective means around to protect against shoreline erosion over time.
5. We also heard that "It doesn't have to be all or nothing" - every little bit of shoreline restoration helps!

With this in mind, we thought we would see if there were any people on the lake who might want to join us in learning about "Lakescaping." It is our hope that our efforts will help to restore Sugar Lake's pristine water clarity of the past- The MN Pollution Control Agency's November 2003 "Water Quality Trends" report listed Sugar Lake as one of three lakes in Wright county with a "Negative Trend in Transparency". The other 24 lakes in the county were listed as "No trends" or "Improving Trends."

We would like to meet once a month, with a "garden tour" of the group's projects at the end of the summer! Possible agendas could include:

- Launching a boat or two on Lake Sylvia (a neighboring lake in the "Improving Trends" category) to check out their "Lakescaping" ideas
- Planning a Warner Nature Center visit to view beautiful native plants.
- Bringing in a speaker to learn more about shoreline restoration
- Meeting new people on the lake and sharing our own knowledge and gardening tips.
- And possibly the most important agenda item of all, the group's name!

Wright County LARA (Lakes and Rivers Alliance)

The Wright County Lakes and Rivers Alliance hosted a Wright County Lakes and Rivers day at the Robert Ney Nature Center March 20, 2004. A full house listened to presentations by:

- Diane Sander with Wright County Soil and Water Conservation district. Diane works with the Crow River watershed and discussed healthy rivers and specific activity in Wright county.
- Chris Meehan with Wenck Associates gave a presentation on when to use a consulting engineer.
- Chip Welling with MNDNR discussed Curley Leaf Pondweed and Eurasian Watermilfoil treatments.
- The LARA leadership presented the proposed LARA structure. A plan for four meetings per year was proposed.

It was reported that the LARA will be taking over administration of the Wright County water sampling program. Time was allowed for questions and answers with the presenters as well as time to network with attending lake associations. Of the approximately 300 lakes in Wright County, about 50 have associations. Most of these are participating in the LARA. The Wright county LARA is looking for primary and alternate representatives from county lakes. Dear Sugar

Dear Sugar, I have been hearing a lot about water clarity and secchi disc readings. What is a secchi disk? From north bay student.

Dear north bay student: A secchi disk is a tool used to measure “water transparency” or clarity. It’s a black and white, or all white, disk (20 cm diameter) attached to a cord that is marked in half-foot or tenth-of-meter intervals. The observer lowers the disk (on the shaded side of the boat) until it disappears and notes the depth on the cord. It’s best if the measurements are taken on bright, calm days.

Bonus info: Hey kids! Would you like to become a “limnologist” (a person who studies lakes) this summer? You can make your own secchi disk, with mom or dad’s help, and measure the water clarity in Sugar Lake. Take a reading in approximately the same spot every week, record your data, and bring your data sheet to the Sugar Lake Picnic this year for a special prize!

Instructions on how to make a secchi disk

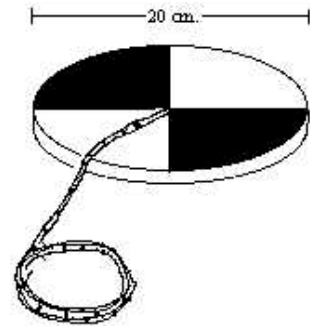
MATERIALS:

1 circular stiff plastic lid, flattened pie plate, or piece of plywood
empty pen housing, or metal casing
scissors
drill with a 1/2 or 3/8 inch bit
50 foot nylon rope
yardstick
duct tape
rock

black and white enamel paints
paint brushes

DIRECTIONS:

1. Cut lid, pie plate, or plywood into circle, 8 inches in diameter.
2. Paint circular piece black and white as shown
3. Drill hole in center of disk and insert pen housing or metal casing. Fit should be snug.
4. Draw rope through casing and tie it to the rock as shown.
5. Use yardstick to mark off half-foot increments on nylon rope. Wrap tape around rope to mark increments.

Sugar Lake to participate in aquatic plant management pilot program

A Pilot Aquatic Plant Management Program (CAPP) has been established for the state of Minnesota. Final details were worked out in an April meeting between the MNDNR and the MLA (Minnesota Lakes Association) Aquatic Plant Committee. The effort to put this program together started last year and is the result of considerable hard work by Dick Osgood of the Lake Minnetonka area, David Devins of Bay Lake, Paula West of MLA, and Dale Gustafson of Sugar Lake / MLA. Three lakes enrolled in the pilot program include Bay Lake, Mission Lake, and Sugar Lake.

The program allows lake associations with an aquatic plant management program to become certified by the MNDNR and enjoy additional responsibilities and opportunities including:

- \$200.00 max on permit fees instead of the \$750.00 max this year.
- Year-long permit to treat when needed within your plan.
- Relief from the delay in permit application. We will be pre-approved.
- Three-year period of signatures validation instead of one year.
- Greater freedom in how and where we treat.
- Additional help from DNR staff when planning our treatment program.

When asked if it was difficult to get this program going and what it means for Sugar Lake, Dale Gustafson responded, “We are very pleased to get this far this fast, and we expect this program to grow to include many more lakes and plan to develop significant education programs for lakes interested in having a CAPP. When I suggested this idea last year at one of the meetings with the DNR staff I didn’t think it would have a chance of getting going for years if at all. The distinction of Sugar Lake being part of this pilot program will give us new opportunities to do more for our lake and put more pressure on us to do it right.”

Wright County adopts zero phosphorus lawn fertilizer ordinance

The Minnesota Phosphorus Lawn Fertilizer Law passed two years ago and went into effect this January. The law requires the use of zero percent phosphate lawn fertilizer in the seven county metro area and 3 percent outside the metro area. Counties outside the metro area have had the option of adopting the same ordinance. This year Wright County joins Crow Wing and Becker Counties as the only counties to do so. Effective this August it will be illegal to use lawn fertilizer with a phosphate component greater than zero percent. Fertilizers are characterized by a series of three numbers on the package. The middle number indicates the phosphorus content. The law is a restriction, not a ban.. The restriction is on the use, not the sale of phosphorus lawn fertilizer. Stores can sell phosphorus lawn fertilizer or not sell phosphorus free fertilizer. It is up to the consumer to purchase the correct product. Bills have been introduced to the Minnesota legislature to expand the requirement for zero phosphate lawn fertilizer to the entire state.

Soil testing on non-fertilized lots around Sugar Lake in 2000 all indicated high or very high levels of phosphorus. Adding phosphorus to lawns through fertilizer is not necessary. Read the fertilizer bag labels carefully and use only zero phosphorus fertilizer around Sugar Lake. Remember one pound of phosphorus equals 500 pounds of algae.

Our Vegetation Committee is planning to treat Eurasian water milfoil and curlyleaf pondweed this year. Our treatment areas are not defined, but our management plan calls for quickly treating the infestation as soon as we make positive identification. In order to be able to respond quickly, we NEED advance permission from all Sugar Lake property owners to treat exotic vegetation in front of their property. All treatment will be approved by the DNR and in accordance with our milfoil management plan.
