
## Diane's Lights Night By Doc Williams

## No Wake Ordinance

The Wright County Board of Commissioners voted unanimously on Tuesday, 26 July to implement a temporary emergency slow/ no-wake ordinance on 15 lakes in the county, including Sugar. This ordinance is in effect for our entire lake. Other area lakes covered by the slow/no-wake ordinance are: Clearwater, Pleasant, Bass, East Sylvia, West Sylvia, Augusta, the Clearwater Chain of Lakes (Caroline, Louisa, Marie and Mill Pond), Nixon, and Locke Lakes.

"Slow" generally means going no faster than 5mph; larger boats with deep hulls or wake-board boats that tend to generate large wakes may have to go even more slowly to minimize their wakes.

The ordinance will be in effect until October 1, 2011 or until the lake level has receded to 6" above the ordinary high water mark and stayed there for 3 consecutive days, whichever comes first.

The Wright County Sheriff will be enforcing the ordinance. Signs are posted at the public landings. Any violation of the ordinance is considered a criminal misdemeanor.

At the Saturday, August 20 meeting, the Sugar Lake Association Board of Directors voted to request an amendment to the ordinance for Sugar Lake. The amendment would establish a slow/ no wake area within 300 feet of the shoreline. This request may be considered by the Commissioner's at their meeting the week of August 29.

# Vegetation Report

Our volunteers have found less Eurasian water milfoil showing near the surface this year. We have hired PLM Lake & Land Management company and they are completing the delineation of the EWM ares that could be treated. We will review their results and decide which area to treat if any. You should watch for information through the Sugar News Flash so you could turn off your irrigation if you are in a treatment area.
