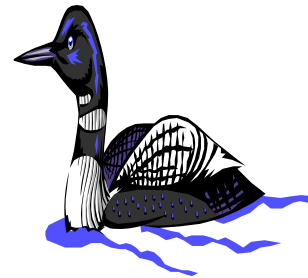

Focus on curly leaf pondweed



Now and for the next few weeks we all need to focus on curly leaf pondweed. Successful control of this invasive plant will require everyone to learn to identify it, participate in removing it, and help pay for treating it. Read the articles in this newsletter, look at the treatment map and identification information on www.sugarlake.org. Contact any board member if you are interested in helping. The next few weeks are a critical time in the life cycle of this plant that offer an opportunity for each of us to have a direct impact by simply removing the plant from the lake.



See someone you don't know searching in the water in front of your cabin? If they are wearing the hat shown to the left say hello to a Sugar Lake Association volunteer who is probably looking for or removing curly leaf pondweed or looking for milfoil. Ask if you can help or for an explanation of what they are doing.

General Membership Meeting

The May Sugar Lake Association meeting was a general membership meeting. After a one hour board meeting covering normal monthly business the focus turned to curly leaf pond weed. 28 Association members listened as Dale Gustafson opened the general meeting with a summary of past and present treatment activity for curly leaf pondweed.

Guest speaker, Mike Palach with Lake Restoration, was introduced. Lake Restoration was hired to treat curly leaf in Sugar Lake this year. Mike described how curly leaf arrived in the United States in the 1870s with carp shipped here from Europe. Since the introduction of curly leaf it has spread to cover about half of the US and a quarter of Canada. The methods used to control curly leaf include harvesting or cutting, herbicides, draw down of lake level to freeze the plant, and dredging to remove silt where the plant lies dormant. An Endothall herbicide was used to treat Sugar Lake this year. This is a contact herbicide applied in liquid form. It is applied early in the spring when the native plants have not started growing but the curly leaf pondweed has. This treatment kills only the plants growing at the time. It does not kill the turions (seed pods) present in the lake bottom. A three to five year program is required to kill new plants that emerge in the spring before they form new turions. Last year 26.5 acres of curly leaf pondweed were identified on



Sugar Lake. The DNR permit allowed treatment this year of 29 acres. At the time of treatment only 19 acres were identified and treated. It is critical to know where to treat and to have a benchmark to measure results against. For this reason a comprehensive lake vegetation management plan, LVMP, is essential. The LVMP incorporates a sampling plan for phosphorus and dissolved oxygen, identifies sources of phosphorus, includes a full plant survey of the lake, surveys shoreline erosion and run-off condition, and includes core samples of lake sediments. Mike concluded his presentation with some information about Lake Restoration. The company has been in business many years. They operate seven trained crews with a total of 55 years of crew management experience. In 2004 the company treated a total of 1900 acres including 600 acres treated for curly leaf pond weed.

The membership discussion that followed the presentations identified three objectives for the Sugar Lake Association:

1. As much curly leaf pondweed as possible needs to be harvested and removed from the lake. Every plant that can be removed is one less to die back adding phosphorus to the lake and release turions that will grow in future years. If you are interested in information about removing curly leaf pondweed contact Marlin Grant at 320-274-7242.
2. Additional fundraising will be required. Based on our best estimates at this time a worst case scenario will require the SLA to spend \$15,000 per year for the next three to five years to achieve control of curly leaf pondweed and maintain the Eurasian milfoil treatment program. Karen Pitra volunteered to lead the fundraising effort and several other members expressed an interest in helping. If you are interested in helping with fundraising contact Karen at 320-274-8153.
3. A comprehensive lake vegetation management plan (LVMP) needs to be done. An LVMP not only guides and measures our treatment activity but also serves as a tool for working with the DNR in the permitting process. The LVMP also thoroughly documents native plant species and populations. The status of native plant populations is an indicator of overall lake water quality. The cost to have the plan done is \$10,000. To offset this cost a grant of \$5,000 is available from the Initiative Foundation. Work already completed by the SLA and information from our existing lake management plan can help offset some of the additional money required. The preparation of the LVMP would be directed by Steve McCommis of Blue Water Science with lake survey labor provided by Lake Restoration. Don Peterson and Dale Gustafson agreed to work on the Initiative Foundation grant. The board unanimously passed a motion to begin work on the lake vegetation management plan.

Vegetation Committee

Curly Leaf Pondweed

The Vegetation Committee has been hard at work this spring identifying and coordinating the treatment of curly leaf pondweed. We have identified 26.5 acres last year and this spring and based our treatment on those acres. At the time of treatment we could only identify and treat 19 acres.

As of the Memorial Day weekend we could see good results from the treatment. It is important to understand that we only need to harm the plants enough to prevent turion production to be successful. The strength of our treatment varied with the water depth, and the result will also vary. In some cases we could not treat all the Curly leaf because it was too close to other desirable natives that would be harmed. All things considered we feel that the treatment part of our control went well.

Now we enter the next stage of our work. We need to identify any new areas of Curly leaf that were not on our list. This past weekend we identified three new areas that we will focus on in removal and treatment. If you find areas of Curly leaf please remember to tell your area communicator or someone from the Vegetation Committee so we have all the areas on our map. This plant will continue to grow rapidly in the next couple weeks before it starts to die back.

We want to identify the remaining healthy curly leaf and cut and remove it from the lake. We all need to work on this for the sake of the lake. After talking with a vegetation committee member, take care of the areas by your property and/or volunteer to help Marlin Grant and his crew on other areas of the lake. It is a huge job, but if we all do a little we can make a difference. Remember, if this plant remains in the lake, as it dies it releases nutrients, and also makes deposits that provide silt for new infestations in the future.

Eurasian water milfoil

We will be treating the EWM again this year. We have identified several patches at this time that we intend to treat in the next few weeks. The areas of treatment will be similar to last year with a few new areas to be treated also. Buddy Divers did a follow-up dive based on the information they provided last year. They did this dive at no charge, but as part of their original service to our lake.

We need to be looking for EWM over the next few weeks so we can treat as much as possible. It looks like we have been successful in preventing the EWM from getting out of control, but we want to remain diligent to keep it under control. Remember, report the location of the plants for our records and be sure to get all the roots of this plant out. It is not like the Curly leaf, EWM is a perennial plant that re-grows from its roots each year. We have seen locations that have gotten worse from simple raking. If you need help, please ask.

LVMP

The Sugar Lake Board should be commended for being supportive of the efforts of the Vegetation Committee. We are encouraged by the support for hiring professionals to help us with our LVMP. This information will allow us to make the correct decisions in the future. To honor our commitment of keeping Sugar Lake as healthy as possible it is imperative that we have good data.

Encouraging News

As we have been looking for these non-native invasive plants we are encouraged by how many and how diverse our native plants communities are. We are seeing areas of re-growth of healthy native plants where we have been treating the exotics. These are signs of hope.

Give Our Lake a Break

Find ways to stay away from the sensitive vegetation buoys. They mark the Hard Stem Bulrush that is disappearing in our lake. We need them badly.

2005 Rainfall

Water Patrol

Remember to renew or obtain your swim raft permit. Contact the Wright County Sheriff's Department at 763-682-7622. Your permit # must be displayed and the raft must be reflectorized to reflect light from all directions.

Minnesota child PFD bill

This is a new law passed May 6, 2005.

1. Requires life jacket to be worn by children less than 10 years of age when aboard watercraft in Minnesota when the craft is underway (not tied up at a dock or permanent mooring).
2. Exemptions from wearing:
 - When in an enclosure or below decks on a watercraft.
 - When in an anchored boat that is a platform for swimming or diving.
 - When aboard a charter (passenger) craft with a licensed captain.
3. Penalties
 - Written warning only for FIRST offense until May 1, 2006
 - Petty misdemeanor for second offense during period above and any offense on or after May 1, 2006.
4. Effective date: May 6, 2005.
5. Interaction with federal regulation requiring children less than 13 to wear life jackets — Federal regulation automatically adopts state law as the standard.

Deputy Joel Mackereth with the Wright County Sheriff's Office met with Sugar Lake Water Patrol members Saturday May 21. In addition to the local benefits of having our water patrol members on the lake their volunteer hours are logged and turned into the sheriff's office. The volunteer hours help guide the allocation of resources in the sheriff's office and are turned into the state where they impact funding decisions. Deputy Mackereth reviewed procedures and guidelines for dealing with situations on the lake.

Start Your Septic System Out on the Right Foot for Spring

The long winter wait is over, and there are a number of things home and cabin owners can do to prepare septic systems for spring. Here are some tips:

- Take a walk around your system. How close are the trees? Remember, hardwoods such as oaks and maples have a root system that extends as far out underground as the canopy of the tree does above. Are there water-seeking trees such as willows nearby? Their roots will extend out searching for available water, and can quickly invade your drainfield area.
- What about gophers and other underground pests? Look for any runways or access holes near your system. Use methods to remove them if prevalent.
- When doing your spring cleaning, keep an eye on how many chemical products you use. Limit the amounts and use more elbow grease. Antibacterial and bleach cleansers do not do a better job than more natural products. Read the product labels; anything listing chlorine includes bleach. For many jobs such as dusting or wiping walls down, plain water is just as effective. Don't wash all the bedding and curtains on one day – spread it out as you do the normal laundry. Have a goal of no more than one load of laundry per day.
- Now's the time to repair damage from freezing last winter; look for a licensed installer.
- If there was freezing, consider adding insulation to the tank or to piping. Look for signs of compaction especially over the piping areas; repair if needed. Look for other repairs needed to prevent freezing next winter. Talk to a licensed septic installer.
- Remind everyone to stay off the drainfield or mound area. Foot or vehicle traffic can cause compaction. Lawn mowers are fine, but nothing else should travel over the area.
