(Dreissena polymorpha)

This little Mussel could change Sugar Lake forever!

There is no treatment, there is no cure, so PREVENTION is the only answer

#### WHAT CAN WE DO & WHAT CAN YOU DO?

We are the only ones that can do anything about this pest spreading to Sugar Lake. Volunteers from your Board of Directors attempted to look at every piece of equipment that came out of the lake this fall. It appears that we do not have them yet, and we want it to stay that way. We need everyone to be on the lookout. No items should be put into the lake without a complete decontamination. Know what to do and spread the word. Remember to decontaminate your equipment when you come from any lake or river.

Topic: Lake Level Forum

Lake levels have been and continue to be an issue of concern for Sugar Lake residents, property owners, and users. Most recently we dealt with high water levels resulting from historic amounts of rain, as well as the ongoing concerns about the effects and effectiveness of the carp trap. The purpose of the forum would be to provide all stakeholders with the opportunity to discuss the issues (lake levels and carp trap) in a structured and facilitated fashion, with the intent of developing a consensus-based action plan.

#### Chairman's Corner

Greetings,

Late in September several years ago, we threw an 'I-Can't-Believe-Summer-Is-Over!' party at our Sugar Lake cabin. That particular summer just seemed to have zipped by us. While we didn't throw the party this year, the sentiment is the same: Where'd it go??



Maybe it was the rains that cut it short. Seems that the afternoons we wiled away floating on the lake, enjoying the sun and water, were just too fleeting. Guess it will be a while before we enjoy 80°, swim trunks, tank tops, and flip-flops (in Minnesota, anyway!!). Whether you fished, swam, skied, sailed, wake-boarded, or just enjoyed the view, we hope your summer was a good one.

Of course, we will all remember the summer of 2011 for its record-high water levels and the limited activity that came along with them. While the No-Wake period was relatively short, it did impact us all, and has spawned some activities:

No-Wake Ordinance - Later this winter, the Wright County Board will be considering a permanent 'No Wake' ordinance. The ordinance would apply to many lakes in the county, and would take effect if, and when, lake levels exceeded a certain depth above their 'Ordinary High Water Mark'. The SLA Board has formally requested to participate in the rulemaking process. We'll do our best to keep you posted with News Flashes in advance of county board meetings with that topic on the agenda.

<u>Lake Levels</u> - Lake Levels will be the primary topic for the SLA Winter meeting in February. Our plan is to have representatives from the DNR and the Wright County S&WCD in attendance at the meeting. Topics will likely include how 'official' levels are set and recorded, how and why lake levels fluctuate from month –tomonth and year-to-year, and what role Sugar Lake plays in the Silver Creek watershed. We'll also spend time discussing the Carp Trap with experts from the DNR and, hopefully, the U of M.

We're changing locations for the Winter Meeting. This year, we'll be holding it at the Corinna Township Hall. It's a beautiful facility and bigger than Cabela's. Mark your calendars for Saturday, February 4.

## Sugar Lake Association has participated in:

- Wright County COLA Invasive Species Forum The SLA participated in an October forum hosted by the Wright County COLA. Clearwater, Granite, Cedar, and Sugar Lake presented detailed descriptions of their invasive species treatment programs. 30 people from 18 different Wright County Lakes attended.
- Minnesota Waters Lakes and Rivers Metro Summit
   The SLA participated in the Metro Summit held this October. A 4 person panel presented information on topics from Zebra Mussels to Lake Association success stories. Don Peterson with the SLA was one of the panel members
- MNDNR Rules Dale Gustafson has served on the State of Minnesota Aquatic Invasive Species Management Stakeholders Committee (New DNR Rules Committee) The work has taken a lot of time but the changes to the rules will be a big help to Sugar Lake and other lakes attempting to control invasive plants and animals.
- MN COLA Collaborative There is a new state organization being formed to help with the efforts to protect and improve Minnesota's lakes and rivers. The Minnesota CO-LA Collaborative is an association of County Collations of Lake Associations in Minnesota. Their goal is to give a clearer message to the State agencies and Legislature that we need to do a better job of protecting Minnesota's Lakes and Rivers.

## Zebra Mussels in Sugar Lake? Lets do all we can to prevent that.

Sugar Lake is especially at risk for several reasons. Our lake appears to be an ideal environment for the Zebra Mussels so our infestation could be worse than many. We have a lot of boat traffic that could easily come from infected water such as Mille Lacs, Lake Minnetonka, or the Mississippi River to name a few. With 72 lakes and rivers with Zebra Mussels in Minnesota, almost any boat could be spreading them. We have so many people using our lake and so many pieces of equipment being put in the lake that everyone needs to know that every item needs to be decontaminated before being placed in the water. Having your dock out of the water for the winter takes care of the equipment that you put back into the lake, but any item taken out of an infested lake could spread them into our lake in the summer.



If Zebra Mussels get established in Sugar Lake we could expect these changes: Water clarity would increase and our native and invasive plants would thrive deeper in the lake and much thicker. This alone could be worse than Eurasian water milfoil or Curly leaf pond weed. All boats, docks, lifts, rafts left in the water would get coated with layers of Zebra Mussels making them difficult to handle and remove. Irrigation systems would get clogged and not function. Any outboard motor with the lower unit left in the water would be coated and clogged and ruined. All surfaces would get covered with shells requiring all swimmers to wear shoes and perhaps gloves to prevent getting cut on the sharp edges of the shells. Not a pretty thought!!



#### More about Zebra Mussels

This little "clam" is usually less than 1" long but can get close to 2" long. Normally people will notice them when they are about the size of a fingernail. When they are just getting established on a smooth surface, they feel like sand paper.

Each female can produce about 500,000 eggs in a season. They are actively producing eggs from late spring to early fall. The eggs hatch into microscopic free-swimming organisms called veligers. At this stage (most of the summer) Zebra muscles can be spread with water. They "settle", get established, and start to reproduce within 6-7 weeks. This ability puts them among the most prolific of all animals.

The veligers can be spread with water and the adults (a few weeks old) can be spread with vegetation, mud, or any structure that is moved into another body of water.

Our plan is to pay for more DNR inspector time at our public landings, but we need to be aware of the other places on Sugar that people can launch boats. (perhaps we could have a sign by each of these)


We need everyone to be aware of how Zebra Mussels can spread

## 2011 invasive species treatment recap

The maps above show the actual areas treated in 2011 for curly leaf pondweed (on the right) and Eurasian water milfoil (on the left).

Last spring the SLA hired Lake Restoration of Rogers to treat our Curly leaf pond weed infestations. They treated 57.9 acres with Navigate (2,4,D) in liquid form.

Last fall the SLA hired PLM Lake and Land Management to treat 4.0 Acres of Eurasian water milfoil with Renovate OTF, (a triclopyr product in granular form).

The association did not do EWM treatment by ourselves this year due to weather and schedules. We would however expect to do our own treatment next year.
