

<u>Ice safety tips from the</u> <u>Minnesota DNR</u>

Recommended minimum ice thickness

4" of new clear ice is the minimum thickness for travel on foot

5" is minimum for snowmobiles and ATVs

8"- 12" for cars or small trucks

(Remember that these thickness' are merely guidelines for new, clear, solid ice. Many factors other than thickness can cause ice to be unsafe.)

Curleyleaf Pondweed Workshops

The Minnesota Lakes Association, University of Minnesota Extension Service, and Initiative Foundation will host a series of workshops in early 2004 on Curleyleaf Pondweed, an "invasive exotic" aquatic plant that can choke out native vegetation and adversely impact fisheries, wildlife habitat, and recreational uses. An increasing number of lakes in Minnesota are infested with this exotic plant. The workshops will help shoreland owners and lake associations understand the unique life history of curlyleaf pondweed and recognize the special challenges involved in attempting to control this exotic plant. This workshop will also cover options for management and the permitting process. Participants will have a chance to talk with other shoreland owners and lake associations about their experiences with curlyleaf pondweed management. The workshop cost is \$15.00. An active member in the aquatic community, Patricia contracted damaging amounts of algae due to high phosphorus levels given off by leaves and grass clippings that entered her system. In lieu of flowers, loved ones are asked to rake or sweep leaves from nearby streets and stormwater drains, and to mulch or compost this fall.

MLA / DNR update

The Minnesota Department of Natural Resources is in the middle of a three-year evaluation of its Aquatic Plant Management Program. This review was mandated by the legislature and started with a report to the legislature on October 15, 2002.

Since that time several issues have been addressed, including aerial surveys of sample lakes and the development of an extensive questionnaire and sampling method to determine the attitudes of lakeshore owners regarding aquatic plant management. Dr. David Fulton from the University of Minnesota has been hired to conduct this survey effort.

As a member of the Minnesota Lakes Associations Aquatic Plant Management committee I have had the opportunity to work with association members from around the state to develop a position on plant management. Our committee had the opportunity to meet for two half-day sessions with the DNR, and it was especially encouraging to see eight to ten DNR staffers spend that much time listening to our input.

One of the current joint efforts between MLA and the DNR is a pilot program for "certified" Aquatic Plant Management programs developed by lake associations. This "certification" would allow for greatly expanded authority and responsibility for managing lake vegetation. It is probable that there will be a pilot program in effect this year and Sugar Lake could be a pilot association.

Watch for more information on this subject. If you are selected to complete a questionnaire, please be sure to help out with that effort.

Protect Septics From Freezing Again

The winter of 2002/2003 was a very hard year for onsite septic systems due to the lack of snow cover combined with cold temperatures. In some counties, up to 30 percent of the septic systems were frozen. Even in a normal Minnesota winter, freezing can occasionally be a problem. Identifying and correcting a potential freezing problem is far easier that dealing with a frozen system.

Some of the common causes of septic system freeze-ups can be: lack of snow cover, compacted snow, compacted soils, lack of plant cover, irregular use of the system, leaking plumbing fixtures, pipes not draining properly, cold air entering the system, and a water-logged system.

What To Do if the System Freezes?

If your septic system freezes, the first step is call an onsite professional. If you have a pump and hear water constantly running in a pump tank (a sign that the system may be frozen), disconnect your pump and call an onsite professional. Many pumpers and installers have steamers and high-pressure jetters to try to unfreeze system piping. Unless the cause of freezing is corrected, the piping will refreeze. Other methods used to help fix a freezing problem include adding heat tape and tank heaters. If the treatment area is full of ice, or there is evidence of leaking, there is no need to thaw the lines leading to the treatment area as it cannot accept liquid until the area is thawed in the spring.

If it is not feasible to correct the problem, the only other option is to use the septic tank as a holding tank until the system thaws naturally. In this case, reduce water use and in the spring, find the cause of the freezing problem so it can be addressed to prevent future freeze-ups.

There are many misconceptions about how to deal with a frozen septic system:

- Do not add antifreeze, salt or a septic system additive into the system.
- Do not pump sewage onto the ground surface.
- Do not start a fire over the system to attempt to thaw it out.
- Do not run water continually to try to unfreeze the system.

What Can You Do to Prevent Freezing?

There are several steps you can take to prevent septic systems from freezing. It is not necessary to do all of these, pick and choose what is best for your situation.

- 1) Place a layer of mulch (8-12 inches) over the pipes, tank, and drainfield area to provide extra insulation.
- 2) Let the grass in your lawn get a little longer in the late summer/fall over the tank and drainfield to provide extra insulation.
- 3) Use water, the warmer the better! Usually water conservation is the best practice, but if freezing is a concern, spread out water use, possibly doing a warm/hot load per day, using your dishwater and maybe even taking a hot bath. Do not leave water running all the time because it will overload the system.
- 4) If you know you are going to be gone for an extended period of time, plan accordingly to have someone use sufficient quantities of water in your home or pump out your tank before leaving.
- 5) Fix leaking plumbing fixtures or appliances in your home.
- 6) Keep all types of vehicles and high traffic people activities off of the septic system—it's a good rule to follow year round.
- 7) Make sure all risers, inspection pipes and manholes have covers on them.
- 8) Keep an eye on your system. If any seeping or ponding occurs, contact an onsite professional to determine the cause and remedy.
