#### Give Our Lake a Break

Protect your septic system from freezing this winter by:

- Place a layer of mulch over the pipes, tank, and drainfield for insulation.
- Leave the grass over the drainfield a little longer for extra insulation.
- Fix leaking plumbing fixtures
- Keep all traffic of the drainfield
- Make sure all septic system risers, inspection pipes and manholes are securely covered.
- Use warm water. If freezing is a concern spread out water use, wash a warm/hot load of clothes each day, use the dishwasher, take a hot bath. Don't leave water running all the time because it will overload the system

# Ice safety tips from the Minnesota DNR

#### Recommended minimum ice thickness

4" of new clear ice is the minimum thickness for travel on foot

5" is minimum for snowmobiles and ATVs

8"- 12" for cars or small trucks

(Remember that these thicknesses are merely guidelines for new, clear, solid ice. Many factors other than thickness can cause ice to be unsafe.)

# The year in review

#### **Water Quality Improvement Committee**

#### North Bay project:

2004 started with a major fix on the north end of creating a 5 acre natural buffer on the south side of the north bay. With the help of Gene Smith who farms the land, and Mr. & Mrs. Larry Sanfort, the land owner, the Sugar Lake Association and Wright County Soil & Water Conservation District funded the planting of native flowers and grasses on a highly erodable section of land between \$115^{th}\$ and \$117^{th}\$ streets where the water flows into the north bay. Arv Klemz reported that after a 2.25 inch rain the water came off the field completely clean. This is a vast improvement from the past.

#### The year in review (continued)

#### • Hollister Ave project:

A major breakthrough was accomplished through the dedicated work of our County Commissioner and Association member Karla Heeter. Karla has been working with us on the ongoing issue of the Hollister Ave project on the south end of the lake. This project has been our number one goal for several years and we have been frustrated by not being able to get a plan developed that was successful to all involved. Karla has been talking for some time with the landowners of the farmland that is part of this issue. She arranged a meeting on Saturday, October 16, with them so we could share our concerns. The Bergs genuine concern about the overall welfare of Sugar Lake was very encouraging. At the meeting they generously agreed to allow us access for surveying and engineering review on their land so we can begin to develop the detail plans needed to find a solution to this problem area. Look for more to happen this winter. We will start the planning and design stage, and start a series of meetings for all the landowners involved as soon as we have good data to discuss. This problem involved a large number of landowners and there are years of history to this problem and lots of ideas about how to solve the problem. The WQIC looks forward to serious meetings with all involved and we are optimistic that with concerned cooperation like the Bergs have demonstrated we will find a solution to this ongoing problem. A good outcome to the Hollister issue can mean a great deal to the water quality of Sugar Lake. A meeting has been scheduled with Wright County Soil and Water and the consulting engineers for early November.

#### **Vegetation Committee:**

The vegetation committee reports that 2004 was a good year on all fronts except one. The one problem area continues to be the amount of Curly Leaf Pondweed we have in Sugar Lake. The committee will be meeting with the DNR this fall and winter to discuss our plans for the aquatic plant management plan for 2005. We currently intend to hire a professional service to treat all the large areas of Curly Leaf in the early spring. We have identified all the large areas of Curly Leaf and have them located by GPS so we are ready to treat. This will be an expensive program, and will have to be done over many years but we feel it is important to attempt to keep this problem in check. If you have property in one of the shallow and soft bottom areas of the lake, you know how much of a problem Curly Leaf can be. We also need to take a serious look at how our boating activities, in these areas, effects the spread of invasive vegetation.

• Buoys - The lake buoy pickup and storage will be handled differently this year.

Volunteers will use the Association pontoon with a new wench system to remove and clean the buoys and then place them on the shore in the areas where they are used. We want to thank the Area Communicators for securing volunteers that will store the buoys until spring. Abundant volunteers make the job easier—thanks to all.

#### Sugar Lakescapers:

The Vegetation Committee and the Sugar Lakescapers were also hard at work this year. We did our first shoreland planting on the Quiggle property with shoreland and in the water planting of vegetation in an attempt to reestablish a filtration area by an inlet to the lake. We had lots of people that helped and we had a good time. The group also planted a bulrush planting to supplement the shoreland vegetation work done by the Rivers on their project on the south end of the lake. Be sure to watch these projects next year and get involved in doing more of this around the lake. Several meetings were held in addition to tours of other lake projects. WE REALLY NEED TO GET BACK THE THIN GREEN LINE of Sugar Lake.

#### Education

It has been a very busy year for the education committee. A few of the activities include:

- Conducted hands-on water quality training with 75 Annadale Middle School Sixth graders.
- Mailed several educational postcards.
- Developed three experiments for children to do their own water quality testing.
- Established a Sugar Lake Association scholarship program. The \$500 scholarship was awarded to Kristin Beltrand. The top three entries are posted on the web site. www.sugarlake.org
- Encouraged the use of phosphorus free automatic dishwasher soap by buying in bulk and offering it for sale to the membership.
- Established a network of area communicators around the lake to serve as a contact point for two-way communication.
- Started work on a 2005 educational calendar
- Several members completed outside training programs. Four members completed shoreland volunteer training, two attended a curlyleaf pondweed workshop, and one completed work to receive a Minnesota erosion and sediment control certificate.

#### Lake Management Plan:

An update to the Sugar Lake Association lake management plan was completed and ratified by the board this year. The completed plan was turned in to Wright County Soil and Water and the Initiative Foundation to complete work required for the Healthy Lakes program.
