

Before that happens the Lake Association has one last event for you to enjoy, and it's the most beautiful of the season. On Saturday evening of Labor Day Weekend, all lakeshore owners are invited to decorate their property with luminaries and celebrate Diane's Lights Night. If it rains on Saturday after 12 PM this event will take place on Sunday. Your display can be as little as a few luminaries on the end of your dock to something grand. A number of people in the past have done what they considered just a fun display and ended up winning, so why not give it a shot? Your grandchildren are a great source of help. A number of past winners have been designed and constructed by them. For the most outstanding displays a 1<sup>st</sup>, 2<sup>sd</sup>, and 3<sup>sd</sup> place winner will be chosen. All winners will get bragging rights but 1<sup>st</sup> place will get 12 cases of Pepsi product donated by Bernicks Beverage of St. Cloud. The rules are simple for contestants. All lighting for your display must come from a flame of some sort

— candles, torches, campfires, or anything else that creates a flame. Any electric lighting will disqualify you for the contest. ## **Report to the Membership: Accomplishments and Future Plans**

August signals the end of the fiscal year for the Association. As part of the year end process, the August meeting of the Board of Directors includes a membership meeting to conduct any business that may require action of the membership-atlarge. As part of that year-end process, it is customary for organizations to review the year gone-by, and look forward to events of the coming year. In that vein, we would like to share this year's accomplishments, and some of next year's plans.

#### 2018 Accomplishments

During the course of the 2017 – 2018 fiscal year, the Association's standing list of events was accomplished in good order. Those events include: Fishing Tournament, Golf Outing, Annual Picnic, 5K Run, and Diane's Lights Night.

In addition to standing events, a variety of routine duties were also performed by a host of member volunteers. Those activities include: Carp Trap Inspection and Cleaning, Water Quality Measurement and Sampling, Apparel Sales, Vegetation Committee, and Watercraft Inspection Coordination.

The Board of Directors also accomplished a number of significant items on behalf of the SLA membership:

- Developed and adopted a 'Rapid Response Plan' for addressing potential future infestations of Aquatic Invasive Species.
- Migrated various administrative and financial functions to digital platforms: cash and banking functions were moved to on-line banking; membership functions were moved to a single, user-friendly web application; the on -line payment feature for Dues and Donations was initiated on the SLA website; and responsibility for bookkeeping functions was transferred to our accountant.
- Increased SLA membership to 283 members/families. 34 new members this year; up 54 from two years ago. Along with the membership increases, total contributions to SLA in 2018 topped \$51,000. This is the largest amount recorded in a single year. Developed a formal list of 135+ membership prospects, and reached out to prospects with an invitation to the annual picnic.
- Voted to support the Wright County Regional Inspection Pilot Program (WRIP) requiring inspection of all watercraft entering Lake Sylvia, Pleasant Lake, and Lake John. As part of this support, the Board made a formal request to the Wright County Board to be included in the pilot program if and when expansion is allowed. Also represented Sugar Lake interests on the WRIP Governance Council.
- Initiated efforts with Wright County to improve highway signage approaching the North Landing.
- Moved the Invasive Species Treatment approval process to a 'public notice' approach, eliminating the labor and expense required for individual mailings.
- Updated and refreshed the SLA website.

Thanks to the Board members, Event Coordinators, and all of the dedicated volunteers who give of their time for the betterment of Sugar Lake.

#### Plans for 2019

In addition to discharging the routine duties of the Board, the following items are being considered for the upcoming year:

- Refine the Invasive Species 'Rapid Response Plan', adopting the electronic forms developed by Ramsey County to streamline the notification process that is required in the event of an infestation.
- Develop water quality improvement projects for consideration by the Board.
- Initiate a Strategic Financial Planning Committee. Operating expenses of the Association have increased significantly with the spread of Aquatic Invasive Species in the region. The goal of the committee would be to develop a plan to sustain the Association financially for the future, with a particular eye toward the needs required to respond to potential future infestations of unknown Aquatic Invasive Species.

# August 2018; SSW in found in Pleasant Lake

During the first week of August, the invasive plant Starry Stonewort was found in Pleasant Lake. The link to the DNR press release is provided below:

While the infestation is small, and can be pulled out by hand, it is worrisome nonetheless. Pleasant Lake is the second lake in close proximity to Sugar Lake to have been infested by Starry Stonewort, with Lake Sylvia being the first. It points up the need for us all to remain aware, and be on the lookout for unusual vegetation in the lake.

Earlier this summer, Blue Water Science conducted an underwater survey of the vegetation in Sugar Lake. The divers sampled plants in over 200 locations around the lake. No Starry Stonewort was found. The Association has periodically conducted these surveys. The results of these surveys have allowed us to better understand the variety of native vegetation in Sugar Lake, as well as to keep tack of the growth and movement of invasive species. These surveys will be conducted routinely for the foreseeable future.

The Sugar Lake Association Board of Directors adopted an invasive species 'Rapid Response Plan' last year. The plan outlines the steps to be taken to address a potential future invasive species infestation (be it Starry Stonewort, Zebra Mussels, or other) in a timely fashion to minimize impact to the lake.
