## WRIP Regional Inspection Site Opens

As you have read in the SLA Newsletter in previous months, the Wright County Board of Commissioners passed an ordinance last year making it a requirement for all boats, trailers, docks, lifts, and other water-related equipment to be inspected at the regional station before launching into Sylvia, John and Pleasant. The ordinance was passed to help prevent the spread of Aquatic Invasive Species (AIS) in Wright County. In order to implement the ordinance, the Wright County Regional Watercraft Decontamination and Inspection Program (WRIP) was created. The program is a joint effort between the Wright Soil and Water Conservation District, the City of Annandale, and the lake associations of Lake Sylvia, Pleasant Lake, and Lake John. Significant financial support is also beeing provided by the Initiative Foundation Aquatic Invasive Species Program (Lessard-Sams Outdoor Heritage Council).

Representatives of other area lakes are participating as members of the WRIP Governance Council. Area lakes represented include: Sugar, Cedar, Granite, and Moose. Ron Elsner currently represents Sugar Lake interests on the Council.

To implement the program, a regional inspection station was created in the City of Annandale Industrial Park. The station is located at the east end of Business Blvd. The station has two lanes for inspection, and is staffed by at least two DNR certified watercraft inspectors. The Wright County decontamination station is now also located at the inspection station.

On Thursday, May 10, the WRIP inspection station opened for the 2018 boating season. Given that the station opened just before the fishing opener, additional inspectors were on hand to be certain that boaters could move through the site in short order. About 120 inspections were conducted over the weekend. The station will be open from sunrise to sunset, 7 days per week until the end of October.

All boats heading for Wright County lakes are welcome to be inspected at the site. Sugar Lake boaters and their guests are encouraged to have their boats inspected before launching, particularly on those days and at those times when inspectors are not present at the Sugar Lake launch ramps. Please remind your guests to bring a clean boat to Sugar Lake!

If watercraft decontamination is required, decontaminations will be conducted during normal open hours at no charge on a 'first come; first served' basis.

On Friday, June 8<sup>th</sup>, the WRIP and Wright SWCD will host a Community Informational Meeting to discuss the 'Why, What, and How' of the program. The meeting will be held from 4pm-6pm at the Annandale City Hall (30 Cedar Street Annandale, MN). Information about the impact of aquatic invasive species on our community will be provided, as well as how the watercraft inspection program works. ## Vegetation

With the summer-like weather, the water has warmed up to near the limit for the treatment of Curly leaf pondweed (CLP). However, no one told the plants that it was time to grow! All of the plants are behind by the calendar and they are developing slowly.

We treated on Tuesday, May 22. With the chemical we use for CLP, there are no restrictions for use of the lake water in any normal way, except drinking or watering animals. It only makes sense not to drink lake water at any time, but for a few days after a treatment of any kind it would be wise not to drink the water. The markers for the treated areas are required to be left in place for 14 days. Please attempt to avoid them until they get removed.

Also, this week the Sensitive Vegetation buoys were installed. You will see them around the lake near the stands of Bull Rush. The Bull Rush is a valuable plant in the lake and is important to the spawning of several varieties of fish. They also help stabilize the soil and sediment in the lake which help maintain the lake water quality.

One of the biggest problems for the Bull Rush comes from power boaters getting too close. Where the boats go, the Bull Rush do not survive. Please attempt to keep away from these areas with speeding boats. Fishing is okay, but attempt to fish from outside the Rushes. The less we disturb them the better they should grow. As you go in and out of the shallow areas where Bull Rush grow, go slow and attempt to go in the same channel each time to reduce the threat to the plants and habitat.

Help out by explaining to your young boater, neighbors, and friends who come to enjoy Sugar Lake that we all need to be proactive in protecting the lake habitat. Do what you can for Sugar Lake.

## Stand-Up Paddleboard Safety Tips

One of the most popular watercraft these days is the Stand-Up Paddleboard, or SUP. While they provide great fun for many folks, safety is something many people take for granted while enjoying the increasingly popular SUPs. But a lot of people don't appreciate the dangers of a SUP. The Coast Guard reports that paddle-sports fatalities — including those in canoes and kayaks — have been on the rise in recent years, including 15 SUP-related deaths in 2016. Here are some important safety practices to consider this season:

#### Wear a life jacket

The <u>Number One</u> most important safety practice: **Wear a life jacket**. Why? In 14 of the 15 reported SUP fatalities in 2016, the victim was not wearing one. Every reported SUP incident, even the nonfatal ones, involved a rider falling and getting separated from his or her board. If you fall off a paddleboard and it gets caught in the wind, you can't swim fast enough to catch up to it. If you are able to recover your board, the buoyancy a life jacket provides makes it easier to climb back aboard.

#### Wear a leash

Of course, chasing a board wouldn't be as much of an issue if people practiced the second most important tenet of SUP safety: **wearing a leash**. The leash is a flexible tether that attaches to the back of the board and around one of your ankles, keeping you connected even if you fall. But even if you use a leash, it's still important to wear the life jacket.

#### Wear appropriate gear:

Put on a wetsuit in cooler conditions. Consider a drysuit in cold weather conditions.

#### Paddle with a buddy

If possible, **paddle with a buddy**. It's always good to have someone else around should something go awry. And always tell someone else where you are going and when you expect to return. If you get into trouble and no one knows you're missing, no one will come to help.

#### Follow boat safety and navigation rules

Is the SUP actually a boat? The answer is yes, depending on where you use one. The Coast Guard states that unless used in a swimming, surfing or bathing area, a paddleboard "is a vessel under 46 U.S.C. 2101 and therefore subject to applicable regulations administered by the U.S. Coast <u>Guard.</u>" This means SUP users, unless on or near the beach, are subject to the same safety and navigation rules as regular boaters.
