## D. Landing/Zebra Mussels was presented by Bob Peltier

Cedar Lake in Wright county discovered 1 large adult zebra mussel. Action plan is to amp up the search and communication

#### Starry Stonewort was presented by Ron Elsner

On June 27, 2017 the Wright County Commission unanimously approved a mandatory inspection ordinance. Representatives from several area lakes were present at that meeting and spoke. Later that day, Wright county Soil and Water approved a plan to implement. From there it was sent to the DNR.

There has still been no word. Lake Sylvia Assoc is hesitant to release funds until the DNR signs off on the plan. Labor Day would be the earliest possible date, but now that seems very unlikely.

### E. Water Quality/Lake Vegetation was presented by Dale Gustafson

Steve McComas helped with the Starry Stonewort and Zebra Mussel search and training. None were discovered. But SS grows at a rapid rate, so we must stay vigilant. Dale is still advocating for the DNR authorization of a preapproval plan to treat targeted areas (the landings) DNR is still somewhat resistant.

30 acres of Eurasian Water Milfoil will be treated in the next few weeks.

New areas of Curly Leaf Pondweed have been identified for treatment in the spring of next year.

Property owners can now apply ONLINE for permit to treat for swimmer's itch or weed control.
